## Updated ISSDA Data Deposit Form

We have updated the ISSDA Data Deposit Form. The Data Deposit Form collects information about the dataset and contact details for individuals who we can contact regarding the dataset. Metadata is created from the information entered in the ISSDA Data Depositor Form. Metadata is the information about the data study which ensures its findability, interoperability and reusability. The fields in the form correspond to [Data Documentation Initiative \(DDI\)](#) an international metadata standard for Social Science research data and use CESSDA Controlled Vocabularies.

## New Datasets

The following datasets were recently added to ISSDA and are now available to request.

---

### Irish Architecture Career Tracker (IACT) Survey, 2023

The Irish Architecture Career Tracker survey's primary focus was to understand why people leave the profession of architecture, attitudes towards and perceptions of gender equality within the profession and the wider discipline, as well as sexism and discrimination.

It includes items which look at the architecture as a profession and the occupations which come under its umbrella as a broader discipline. Also examining work culture, such as long working hours, as well as standard measures of work-family conflict and work pressure, and subjective stress. Including new measures of attitudes towards gender equity developed by the European Social Survey Round 11 'Gender in Contemporary Europe: Rethinking Equality and the Backlash'.

The RIAI (Royal Institute of Architects Ireland) provided funding through the IRC grant.

### Growing up in Ireland Cohort '98 (Child Cohort) Wave 4 at 20 years Time Use Data

Growing up in Ireland Cohort '98 (Child Cohort) Wave 4 at 20 years Time Use Data from the Central Statistics Office(CSO). All 20-year-olds who were successfully interviewed in the main study at Wave 4 were invited to self-complete the Time-Use Diary. The Time-Use Diary recorded details on the activities of the 20-year-old over a 24-hour period divided into 15 minute intervals. The Time Use data available from ISSDA contains data from 2,624 diaries.

## **IDS-TILDA Wave 4**

The Intellectual Disability Supplement to the Irish Longitudinal Study on Ageing (IDS-TILDA) is a longitudinal study researching ageing in Ireland among people with an intellectual disability aged 40 and over. This study is the first of its kind in Europe, and the only study able to directly compare the ageing of people with an intellectual disability with the general ageing population. The underpinning values of IDS-TILDA are inclusion, choice, empowerment, person centred, the promotion of people with intellectual disability, the promotion of best practice and to contribute to the lives of people with intellectual disability.

IDS-TILDA Wave 4 provides much needed data on the health, social, economic and environmental circumstances of 739 people as they grow older and how their circumstances change over a period of time.

## **National Maternity Experience Survey, 2020**

The survey is part of the National Care Experience Programme — a joint initiative by the Health Information and Quality Authority (HIQA), the Health Service Executive (HSE) and the Department of Health. The aim of the survey was to learn from the experiences of women to improve the safety and quality of the care that they and their babies received.

The survey questionnaire contained 68 questions which capture the whole maternity pathway from antenatal care, through labour and birth, to postnatal care in the community.

## **Update to Labour Force Survey (LFS)**

The Labour Force Survey (LFS) is a large-scale, nationwide survey of households in Ireland conducted by the Central Statistics Office. It is designed to produce quarterly labour force estimates that include the official measure of employment and unemployment in the state.

This update adds the data for Q4 2024, thereby completing the data for that year. Please be aware that there was a change in format for the Labour Force Survey. It is now being issued in CSV and SAS format. It will no longer be issued in STATA.


